1. RULES:

- 1.1 The series/races will be governed by the 'rules' as defined on the *Racing Rules of Sailing*
- 1.2 The YNZ Safety Regulations shall apply. Keel Boats and Multihulls Part II Category 4. Trailer Boats Part V Category B, in addition keels shall be locked down at all times while racing. In accordance with YNZ Safety Regulations Part II 3.2, a The YNZ Safety Regulations shall apply.
- 1.3 The skipper shall at all times while racing wear an approved PFD or Lifejacket.
- 1.4 A boat shall not discharge rubbish into the water.

2. ELIGIBILITY AND ENTRY:

- 2.1 The series is open to all Keelboats, Multihulls and Trailer Boats.
- 2.2 Advanced series entries will be accepted until the normal closing time of 1700 hrs on Friday 08th Nov 2019 by completing the attached entry form accompanied by a fee of \$50.00 and mailing to The Race Secretary, Bucklands Beach Yacht Club, P O Box 54 005, The Marina, Manukau 2144.
- 2.3 Single entries will be accepted until the normal closing time of 1700 hrs Friday prior to the race by completing the attached entry form accompanied by a fee of \$25.00 (single race) and mailing to The Race Secretary, Bucklands Beach Yacht Club, P O Box 54 005, The Marina, Manukau 2144.
- 2.4 To be eligible to complete in this series each skipper shall be a financial member of a club recognised by the skipper's national authority
- 2.5 Each yacht shall be insured with valid third-party liability insurance with a minimum cover of \$3,000,000 per event. Evidence of insurance shall be provided by 1700 hrs on the day before the race briefing for the first race the yacht intends to compete in. The BBYC / Organising Authority encourages all owners to carry full racing insurance.
- 2.6 After the first race of the series any change of trim, sails, spars, variation to hull, rudder, keel or propeller must be disclosed before 1700hrs on the day before that race is scheduled by completing a declaration form and lodging at the BBYC office or emailing the changes that have been made to racing@bbyc.org.nz.
